Of course we have been impacted by the market volatility with our funds and impacted from inflation, but hopefully we can bounce back one day.

-Our city benefits from the Richfield Foundation grants that are given every year. We gave to a diverse slate of

organizations that benefit a wide range of households in Richfield. We had our first Wine Event post-Covid and it was a success! Thank you to everyone that supported the Richfield Foundation during the event and thank you to all of the board members and volunteers that participated and worked long hours on the event - you are truly appreciated.

- We signed a fiscal agreement with AltLawns; we enter these agreements to help groups that cannot be 501c3 organizations (like Wood Lake Nature Center), or ones that are applying for that status (such as past agreements with the Veterans Memorial or the Richfield Bandshell).

- We had a steady amount of grantmaking in 2022: \$23,045. In our 33-year history, we have now distributed more than \$370,000.

Some of the members that helped us in the last few years departed the Board, and I'd like to personally recognize their efforts: **Rowda Moallin** served on our Grants Committee and helped with updating the application and sending out materials to community groups for our annual grant making and for the matching grant session. **Alex Farrell** served as our Secretary and did a wonderful job taking minutes and updating notes when needed. He kept our meetings on task and provided valuable input in any conversation that was had. **Pam Dmytrenko** filled the City Manager seat. **Liz Sanborn** helped make many wine events possible, and managed our donor database for many years. **Mary Stratton** supported our insurance compliance efforts.

It has been my pleasure and great honor to serve in this position, and I have learned a great deal and enjoyed serving the community. I have gained a great deal - the opportunity to work with fantastic leaders, learn about good work being done in our community, and feel like I am giving something back to the city that has been my family's home for more than 20 years. I look forward to building the Foundation as a resource for our community. We have a lot of work to do.



Finance Report

Richfield Foundation funds are secured in several accounts through BMO Harris Bank. Cash deposits are in a checking account and the endowment fund is administered by the BMO Harris financial advisors.

Richfield Foundation is supported in a variety of ways. Monetary donations by individuals and businesses, special fund raising events, administrative revenue from services as a fiscal sponsor, and in-kind contributions. In 2022, Richfield Foundation assumed the assets of the Richfield Rotary Scholarship Fund, and will administer that program in 2023.

In 2022, the Foundation's investment account took a loss, as the market experienced turbulence. We met several times with our investment advisor through the year to fully understand the impact, trajectory, and best courses of action, anticipating that the market would recover in 2023.
