



Board Chair's Message: "Win-Win"



One of the best parts of being involved with the Richfield Foundation is that we don't horde success.

When we have a good fundraising year, we have more money to give for grants, and we pass it along to groups doing good work in our community. In turn, they do more to nurture healthy youth, support seniors, bring people together, meet basic needs, and make Richfield a great place to live.

In 2017 we had a good year – our best fundraising year in a long time -- and that helped make 2018 a good year. We topped \$20,000 in grants distributed for the first time – to be precise, we distributed \$22,000.

And we didn't stop there. Our sixth annual Wine Event, in October 2018, was the most successful ever, netting more than \$13,000. So we expect that 2019 will be another good year for grantmaking.

In other words, our work is pretty simple – we get more money, we give out more money. But that doesn't mean it is easy. When we have a good year, it is the result of many people who give of themselves to make that possible, and I am very grateful for this.

In this report you will get a glimpse of that work – the committees that organize the Wine Event, sort through the grant requests, handle our finances, and more; the businesses and individuals who sponsor and donate to our work. These are the people who make our success possible, and who help us share that success in the broader community.

Fortunately, there are many people who have played a part, and we have had a nice mix of continuity and change in the Board leadership in recent years. I like to make special notice of those individuals who are moving on to other things. **Simon Trautmann** joined the Foundation Board before he won a City Council seat, and is stepping down as the duties of an elected official grow more time-consuming. His legal background has been helpful – he co-led a revision of our bylaws – and he has been an effective recruiter of new voices to include in the Foundation. **Cathy Bender** joined the Board after her husband Jeff had served; we are grateful for the years of work they have provided in our community. Cathy is selfless and willing to help out in many ways; in particular, she has been a valuable recruiter of volunteers and helped organize annual meetings.

Thank you for your attention to this report. As you read it, I hope you can see a way that you can help us continue this string of success and supporting more good work in Richfield.

The Richfield Foundation was created in December 1988. It is an all-volunteer organization that operates with no salaries and low overhead. Over the past 25 years, the foundation has given out nearly a quarter of a million dollars to local non-profit organizations and programs that strive to make Richfield a great place to live and work.



Grants

Grant's Committee Report

The Grant's Committee received 21 requests for funding in 2018 including 1 for our "Great Idea" Matching Grants program in the summer months and 20 requests for our Major Grants in the fall. The Richfield Foundation Board awarded grants to 14 agencies.

The Great Idea Matching Grants requests are solicited by the Foundation Board and collected by the Chair of the Grants Committee from March through August 2018. They are distributed to the Grants Committee for approval. The Grants Committee has autonomous approval authority sanctioned by the Foundation Board to make these small, matching grants. The Foundation Board sets a total dollar limit on all Great Idea Matching grants and the committee must stay within that limit for their awards.

During September and October 2018, the Foundation Board solicited major grant requests through mailings and the web site. The Chair of the Grants Committee collected and submitted them to the Foundation Board members for their review. In November 2018, the Foundation Board members gathered to discuss and ultimately vote on the merits of each proposal. This process was led by an impartial Richfield resident who is not a voting member of the Richfield Foundation. The checks were dispersed at a Richfield City Council Meeting in early December 2018.

The following is a list of grants awarded in 2018. The total amount awarded was \$22,000.00 \$500 was awarded for the Matchinggrants in the summer and \$21,500.00 for the major Grants in the fall.

Summer 2018 Matching Grant:

Richfield Girl's Fastpitch Softball Association – The funds were used for uniforms and supplies as well as scholarships. *Granted:* \$500

Fall 2018 Grant Program:

People with Capes: Kids at Home – Parent Share – Positive
Parenting: Provide parent
education, child/teen and parent
communication skills and child/
teen and parent social skills
training. Funds will be used to
offset fees paid to English &
Spanish professionals who
provide training.
Granted: \$2,000

VEAP, Bloomington MN:

Food Program including pantry, mobile food deliveries: The program provides fresh fruit & vegetables to an apartment building in Richfield. VEAP bridging the gap between poverty and poor nutrition leading to better health, parenting, handling stress and job performance for participants. *Granted:* \$2,000

Cornerstone - School Based Services: Facilitation of K-12 primary prevention classroom presentations on topics such as teen dating violence, bullying, harassment, anger awareness, healthy relationships. New initiatives in 2018: Richfield Middle School – Healthy Masculinity, a boy's group that provides a safe venue and support for boys to embrace non-violent notions of manhood and Sheridan Hills – a pilot project on Bullying and Anger Management geared to elementary students. *Granted:* \$1,800

Human Rights Commission, Richfield, MN - The program is created to fund a speaker's bureau on topics that are of interest to residents of Richfield such as development, diversity and housing. *Granted:* \$1,500

Loaves and Fishes –Nutritious Meals in Richfield: L&F provides free, nutritious meals to those who cannot meet their daily food needs. There are two dining sites in Richfield: Hope Church and Woodlake Lutheran Church. Funds will be used at these two sites. *Granted:* \$2,000

Oasis for Youth, Bloomington, MN: Community Based Outreach: Oasis seeks to reach youth as soon as possible when they are at risk for being homeless. Funds will be used for critical supplies needed to support youth contacted in the community. *Granted:* \$1,500.00

Partnership Academy, Richfield MN: Partnership Academy is moving into a new building at 6500 Nicollet Avenue for the 2018-2019 school year. With that move they will be able to expand programming to 6th grade and up to 8th grade. The money would be used for program materials. *Granted:* \$750

Richfield Fourth of July Celebrations, Richfield, MN: The funds will be used for general operations. Since 1980, the mission of the 4th of July committee is to advance and promote the observance of Independence Day in the City of Richfield. Funds will be used for expenses. *Granted:* \$2,000

Richfield Historical Society: This project is to continue a student friendly program that can be used at the middle school grade level by expanding the program and presenting history in a fun and interactive way. The program will be presented in English and Spanish. *Granted:* \$1,000

Richfield Middle School Parent Advisory Board: The purpose of this project is to bring in guest speakers to educate, engage, and inspire students and parents in the Richfield Middle School. Speakers will be from the Wetterling Institute to teach students about personal safety. *Granted:* \$700

Tapestry – Spanish and ESL Community Bridge: Language classes housed in Oak Grove Lutheran Church. 20 people in Spanish Class and 15 in ESL class. Funds will be used for expenses. *Granted \$1,500*

TreeHouse - Bloomington TreeHouse: This agency is set up to meet the spiritual, social, emotional, physical and intellectual needs of at-risk teens which is housed in Evergreen Church in Bloomington. They offer several groups to meet these needs and reduce at-risk behaviors. Currently 85 Richfield teens attend Bloominton TreeHouse. *Granted:* \$750

Crossroads Panorama – Youth Intergenerational Writers Storytellers Workshop: Non-profit community-based writers' workshop for youth 13-25. A three-week workshop will provide participants the opportunity to learn the art of storytelling, creative writing and how to publish their stories. *Granted: \$2,000*

Assistance League – Richfield Education Support Projects: Sponsor 3 programs in Richfield Schools:

1) Start Smart: Provides clothing and supplies to students in need 2) Our School Reads: Distributes a single book to all 400 sixth graders and teachers to participate in the Global Read Aloud Program.

3) Links to Learning: teacher grants will provide grants up to \$750 to help fund selected projects.

Granted: \$2,000

Financials

The Richfield Foundation funds are secured in several accounts through BMO Harris Bank. Cash deposits are in a checking account and the endowment fund is administered by the BMO Harris financial advisors. In addition, the Richfield Foundation made the decision to invest in a community resource in 2014; the Lake Winds Food Cooperative.


The Richfield Foundation is supported in a variety of ways: Monetary donations by individuals and businesses, special fund raising events, administrative revenue from services as a fiscal sponsor and in-kind contributions. Additional investment revenue is generated for the endowment fund and the Lakewinds investment.
